C I R C U L A R

Sub: Enhancement in the rates of various allowances on account of revision of rates of Dearness Allowance – reg.

Ministry of Finance, Department of Expenditure, Govt. of India had issued two separate Office Memorandum (OMs) vide number (i) 2/5/2017-E.II(B) dated 07.07.2017 regarding implementation of Recommendations of the 7th Central Pay Commission relating to grant of House Rent Allowance (HRA) to Central Government Employees, and (ii) No.19030/1/2017-E.IV dated 13.07.2017 regarding Travelling Allowance Rules – Implementation of recommendation of the 7th Central Pay Commission.

In compliance of OM No.2/5/2017-E.II(B) dated 07.07.2017 and OM No.19030/1/2017-E.IV dated 13.07.2017 and subsequent University of Delhi's circular no.Estab.II(i)/330/Misc./2024/612 dated 13th May, 2024, the Competent Authority of the Institute has approved to revise the rates of the following allowances pursuant to enhanced rates of Dearness Allowance (DA) by 50% with effect from 01.01.2024:

i. **House Rent Allowance (HRA)**
